CALL FOR APPLICATIONS FOR PROFESSIONAL EXAMINATIONS OF THE BOARD IN OCTOBER 2026

The Board is inviting eligible Candidates to apply for the Professional Examinations in Architecture, Quantity Surveying, Technology in Architecture, Interior Design, Landscape Architecture, Building Survey and Construction Management that will be held in **October 2026**.

1. ENTRY QUALIFICATIONS:

1.1 INTERMEDIATE LEVEL:

A candidate must hold an Advanced Diploma in Architecture, Quantity Surveying, Architectural Technology, Interior Design, Landscape Architecture, Building Surveying, or Construction Management. Alternatively, the candidate may possess a degree from a recognized institution with a training duration of less than five years in Architecture, or less than four years in Quantity Surveying, Architectural Technology, Interior Design, Landscape Architecture, Building Surveying, or Construction Management.

1.2 FINAL LEVEL:

A. ARCHITECTURE:

The Candidate must hold a first Degree in Architecture or equivalent qualifications from a recognized Institution or must have passed the Intermediate Examination of the Board in Architecture.

B. QUANTITY SURVEYING:

The Candidate must hold a first Degree in Building Economics/Quantity Surveying, or equivalent qualifications from a recognized institution or must have passed the Intermediate Examination of the Board in Quantity Surveying.

C. TECHNOLOGY IN ARCHITECTURE:

The Candidate must hold a first Degree in Technology in Architecture or equivalent qualification from a recognized institution or must have passed the Intermediate Examination of the Board in Technology in Architecture.

D. INTERIOR DESIGN:

The Candidate must hold a first Degree in Interior Design or equivalent qualifications from a recognized institution or must have passed the Intermediate Examination of the Board in Interior Design.

E. LANDSCAPE ARCHITECTURE:

The Candidate must hold a first degree in landscape architecture or equivalent qualifications from a recognized institution or must have passed the Intermediate Examination of the Board in landscape architecture.

F. BUILDING SURVEY:

The Candidate must hold a first Degree in Building Survey or equivalent qualifications from a recognized institution or must have passed the Intermediate Examination of the Board in building survey.

G. CONSTRUCTION MANAGEMENT:

The Candidate must hold a first Degree in Construction Management or Equivalent qualifications from a recognized institution or must have passed the Intermediate Examination of the Board in Construction Management.

Additionally, all Candidates for final level Examinations must have attended Architectural or Quantity Surveying Professional Training Exposure under a registered professional for the duration of not less than two years after graduation and must be registered as a graduate during application.

2.0: REFERRALS:

Candidates who attempted the Examinations of the Board in the previous sessions and were referred in certain subject(s) are highly encouraged to re-sit the same in October, 2026 examination session.

3.0: MODE OF APPLICATION:

All applications shall be submitted through the **Online Registration System (ORS)**, accessible at ors.aqrb.go.tz. The system will be open for applications from **15th June 2026** and will be closed on **10th July 2026**. Applicants are required to create and use their individual ORS accounts to submit their applications. Upon successful submission of an application, the system will generate a control number for payment of the prescribed application fee amounting Tshs 20,000.

For final candidates, applications must be accompanied with a recommendation letter from the Supervisor confirming that the applicant has acquired sufficient professional practical experience and is ready to sit for the Board's Professional Examinations.

The deadline for submission of applications is 10th July 2026 at 4:00 p.m. Late applications will not be considered.

All AQIP trainees who have successfully completed their internship programme are strongly encouraged to apply for the examinations.

4.0: SUBMISSION OF EXPERIENCE REPORTS(LOGOBOOKS):

Candidates for Final Level Examinations are **instructed to fill their logbooks using instructions/ checklists provided in their logbooks** Further; Candidates are **obliged to submit their logbooks to the Board for Verification at least 14 days before date of final submission which is on 7th August, 2026 before 4.00 pm (Ensure Use of New Standard Logbooks available in the online registration system(ors.aqrb.go.tz).**

Submission of the Logbooks (**Three copies, one original and two photocopies**) must be accompanied with a non- refundable fee of **Tzs.70,000/=** paid through Control number issued by AQRB. The Diary sheets in the logbook **must be duly filled in by HAND,signed by the Candidate and the Supervisor and be stamped by the Supervisor asthe case may be.**
